Nene Ridge Parishes Group Meeting

'The Nene Ridge Parishes Group', which includes Brafield and all surrounding villages, has been holding regular meetings since the Emergent Joint Core Strategy (EJCS) was first published. A meeting was held at Little Houghton on February 8th to discuss recent developments and share information. Brafield Parish Council was represented there.

There was much discussion about the proposed SHLAA (Strategic Housing Land Availability Assessment) sites, mentioned in the last Newsletter, and each village represented at the meeting has now submitted responses to those sites in their area where valid 'technical' planning comments could be made.

Some of the Group have been preparing a detailed, evidenced, statistical analysis into the EJCS's *proposed* housing figures against *actual* housing requirements, and there appears to be quite some discrepancy between the two. It was agreed that now, whilst the West Northamptonshire Joint Planning Unit is still immersed in dealing with all of the comments submitted on their Joint Core Strategy, was the time to increase the pressure and release this information to the JPU and the JPU Committee with questions requiring answers.

A member of the Group is to attend a major meeting of the Environment Agency to challenge their plans.

Another member attended the East Midlands Regional Assembly's Regional Housing Planning and Transportation Board meeting in January. The Board stated that they would not be producing a policy beyond 2026 because it was 'beyond the scope of the Regional Transport Policy'. This may have major implications for the proposed A45 / M1 link road.

It was generally agreed that the Group should now be more proactive in challenging, questioning, seeking explanations etc. on the issues emerging from the proposed developments; as well as lobbying various bodies for more support. In this connection it was agreed to try to arrange a meeting of the prospective general election candidates from all parties, to hear their views on the development of Northampton South East, and make local feelings clear in return.

Salt Bins / Road Salt

Three new salt bins have been installed so now we hope that each area of the village is adequately served.

However, road salt became an important issue during the "big freeze" in December through to February this year when many roads and pavements were covered in snow and compacted ice.

IT SHOULD BE NOTED: Salt bins are placed at the side of the road for people to use on the public highway (including footpaths) on a self-help basis, but this salt is not provided for use on private properties.

Only small amounts of grit and salt are needed to be effective so please show consideration for others when using salt bins.

Within hours of a few millimetres of snow falling on the 18th February, and with up to a further 10cm forecast for the weekend, our grit supplies in at least two of the bins were emptied despite having been checked by the Parish Council less than 24 hours previously. Please remember the County Council supplies are low due to the extended bad weather and it is probable that Parish bins will not be re-filled again this winter/spring. Please be responsible - do continue to use salt for clearing footpaths and the highways but please DO NOT remove bucket loads for use on private driveways. Local DIY stores supply rock salt and grit for this purpose.

Parish Paths Wardens

We are pleased that we now have two new sets of people who have volunteered to undertake this role as replacements for Helen Frostwick who 'retired' in May 2009.

The Parish Paths Wardens are volunteers who support the County Council on our behalf by acting as local 'eyes and ears' reporting any problems with the paths - obstructions, overgrown paths, surfaces or structures needing repair or replacement - and can help in encouraging their use through local maintenance work, way-marking and, perhaps, leading walks.

Attention Billing Road Residents

On the morning of **Sunday April 18th** an **abnormal load** will be passing along the Billing Road through Brafield towards Cogenhoe with a police escort. The load is an electrical transformer on its way to the Grendon Electricity Sub Station. It is vital that Billing Road is kept free of parked vehicles during this morning. The load is 5.02 metres wide, 66 metres long and weighs 220 tons!

Dog Fouling

The Parish Council has had a number of complaints recently about the increase in dog fouling – especially along the Bridle Path and in front of the Red Lion.

Failing to clear up after your dog is an offence for which you could be subject to a fine of up to £1000. Failing to clean up is also offensive for other people in the village. Anyone who comes into contact with dog faeces could become infected with Toxocara Canis. This unpleasant disease can lie dormant in the soil for up to three years. With spring approaching more people will be out and about and we all want to enjoy our village so PLEASE if you have a dog – clean up after it!
