**Neighbourhood Plans : an Update**

Two Parish Councillors recently attended a seminar in Towcester organised by South Northamptonshire Council (SNC) to discuss the emerging position on Government reforms to the planning system, in particular the introduction of 'Neighbourhood Planning'. Yardley Gobion is a national 'pilot' for the development of this new form of local community planning and is receiving close support from SNC who now have a new legal duty 'to co-operate' in such matters. Raunds, Oundle, Wootton and East Hunsbury are other national 'pilots' within the county.

In addition to experimenting with these 'pilots', the new draft legislation for 'Neighbourhood Planning' is subject to national consultation. It is clear that there are many uncertainties about the likely cost of such plans and how they will be financed. However, there is little doubt now about the amount of work required, over an estimated 12-18 months, to produce them to the standard required for acceptance by the local planning authority – in our case, SNC – to form part of the legal framework of plans.

In South Northants Council area, Parish Councils will be expected to decide whether their community should create a Neighbourhood Plan. If the answer is yes, then they will take the lead in the process supported and guided by SNC. They may choose to work jointly with neighbouring parishes for a wider area plan. However, producing any such plan would not simply be a project for the Parish Council alone. Although some Councillors would be involved, a group of volunteers from within the community would be needed with a chair or co-ordinator who is not necessarily a member of the Parish Council.

The point about Neighbourhood Plans is that they offer everyone the opportunity to have some say in the future development of their own village and community. Indeed, any Plan produced will need to show that it is representative of both the place and the people living there as well as conforming with the District Council's own Development Plans. If not, then it will not be accepted by the District Council to form part of the planning system and acquire legal status. So, in short, plans will involve a lot of time and effort even though the work will mainly be done by volunteers. They will involve lots of meetings, questionnaires, interviews, consultations, analysis and a community referendum. They will also incur significant costs.

The Parish Council is monitoring developments closely and deciding if, when and how it might commit to create such a plan for our village and community. SNC has produced guidance recommending that 'a community should consider carefully the reasons why it wants to prepare a Neighbourhood Plan'. The Councillors are using this in deciding what is best for the village in the short and medium term.

Very soon, SNC is going to be reviewing the extent and nature of existing conservation areas and 'village confines' (in simple terms the boundaries of the central village area outside which development will not be considered as the land is regarded as 'open countryside') across the District. This is something with which the Parish Council intends to have direct involvement and the outcome of this work may influence its decision on whether to create a Neighbourhood Plan.

**Metal Theft : Regulation of Scrapyards**

Prior to Christmas, you will be aware that Brafield and surrounding villages were seriously affected by the theft of underground cabling from the telecommunications network which disabled local telephone and internet connections for some time. This caused considerable disruption and distress to local businesses and residents.

A government petition now exists to promote tighter regulation which states:

'Let's put an end to criminal activity all over the UK by insisting that new legislation is introduced to make Scrapyards registered for business. Criminals are stealing metals from church roofs, hospital generators, railway cabling, drain covers and from headstones and monuments. If Scrapyards were regulated and forced to only take scrap from people that provide ID, have their photograph taken with their scrap items and paid by cheque, this problem would be eradicated'
